Business ideas from National Schools Science Fair



Student of Aux Lyons Combined explains science project to Calabash TV





Education Minister Dr. Robert Lewis is urging the business community to take a closer look at the creativity and entrepreneurial spirit of the island's students particularly those who participate in the annual National Schools Science and Technology Fair.

This year the fair was held under the theme "Science and Technology Advancement – Changing our Lives through Scientific Competitions".

Science projects were judged under categories such as Environmental Science, Home Economics, Science and Technology, Physics, Mathematics and Agricultural Science

Science and Technology Minister Dr. James Fletcher commended the participants drawn from primary to tertiary level institutions for the quality of projects submitted this year and urged the wider student population to embrace science as a very real educational and career option, citing examples such as FaceBook's Mark Zuckerberg, Apple's Steve Jobs and Microsoft's Bill Gates as science students who are now impacting on how we live and communicate.

A number of the science projects showed potential for development as business ideas. For example the Aux Lyon Combined School's project "USING PLASTICS TO MAKE BANISTERS" was judged the first place winner under Environmental Science for Primary Schools. The school hopes to solve an environmental problem and at the same time create a product that is in huge demand in the construction industry.

Calabash TV and the Caribbean Business Report will over the next few weeks feature the submissions to this year's Science and Technology Fair.



Double digit growth in stay over arrivals from major markets

Saint Lucia's vital tourism product is benefiting from double digit increases in stay over arrivals in several key markets based on early figure indicators.

For the months of January and February 2012, the island recorded a twenty percent increase in stay over arrivals which totaled 63,868. In the largest source market, the United States, arrivals to Saint Lucia grew by 13% over the same period last year, recording a total of 22,636.

Arrivals from the island's second largest market, the United Kingdom, totaled 16,549; 4513 more visitors than the same period in 2011 (a 38% increase). The Canadian market also recorded an increase in visitor arrivals from 10,611 to 13,853 in 2012, which resulted in a 31% increase.

Commenting on the increases, Tourism Director Louis Lewis says they were the results of well thought out and targeted market intervention strategies designed to boost Saint Lucia's visibility in major source markets. These increases he says, "come in spite of the many challenges faced in the tourism industry, and underscores the fact that as a destination we are holding our own as we continue to promote Saint Lucia as a preferred destination of choice amidst the global competition."

The Caribbean market captured the fourth largest (8%) share of the stay over arrivals between January and February 2012, with a total of 5,308 visitors. This represented a 6% increase over the same period last year.

Cruise calls increased from 99 by the end of February 2011 to 117 for the same period in 2012, which was reflective in an 11% increase in arrivals over the same period.



LIME pays tribute to Saint Lucia's Queen of Dance & Culture



LIME has dedicated the front cover of the 2012 Services Directory to honouring Mrs. Teresa Hall, one of Saint Lucia's most popular and dedicated cultural activists.

Mrs. Hall is the founder of the Helen Folk Dancers, one of the island's leading dance troupes. She started the group in 1991 with a core ensemble of students and alumni from the Castries Comprehensive Secondary School and other secondary schools, some of whom are still involved in the group to this day.

Inspired by her mother, who was a La Rose queen, Mrs. Hall got involved in traditional dance as a child and often took part in quadrille and other Creole dances.

She has devoted almost her life to teaching and promoting the art form and has helped to foster greater public appreciation for St Lucia's culture, especially among the youths. She is a recognized authority on Saint Lucia's national dress, and has taught art and craft around the island. She has also worked with the Saint Lucia Blind Welfare Association and served as a member of the local Poppy Day Committee.

To this day, Mrs. Hall remains a vocal and outspoken cultural advocate. A mother of nine, she is deeply spiritual and regularly takes part in various religious activities. She also devotes much of her spare time to horticulture, yet another of her many passions.

Barbados shocked by announcement of Almond closure end of April



Employees and shareholders yesterday reacted with shock to news of the impending closure of Almond Beach Village at month end, which puts more than 500 workers out of work.

During an emotionally charged session held in the hotel's conference room, former Opposition Leader Mia Mottley was among those expressing surprise over the announcement by Neal & Massy that the St Peter property would abruptly close on April 30.

She reminded the Trinidadian owners that Barbadians had boycotted cricket back in 1992 in protest of the exclusion of homeboy Anderson Cummins from the regional side.

However, when challenged by the company's president and CEO Gervase Warner on the matter, Mottley, who was representing her father Elliott Mottley, a shareholder, defended her statement saying it should not be construed as any veiled threat leveled against Neal & Massy, even though she did signal to the company that it needed "to act in a way as not to occasion any backlash"

REDjet a motivator for developing intra-regional travel



Chairman of the Barbados-based Caribbean Tourism Organisation (CTO) Sen. Richard Skerritt says the Barbados-based low cost carrier REDjet should serve as a motivator for developing an environment that would

encourage intra-regional travel, noting that during its ten months of operations the airline had showed there is a pent up demand for such travel.

Skerritt, who is also Minister of Tourism and International Transport for St Kitts and Nevis, told the Caribbean Media Corporation (CMC) that REDjet had been able to make a significant dent in intra-regional travel "which is being stifled by both capacity and ticket prices."

"So there is no question that Caribbean people want to travel in the region at the right price, at the right aircraft at the right time." REDjet was a costly experiment for the investors who put REDjet in place.

"It is a pity that REDjet had to collapse as a business so quickly," Skerritt told CMC.


EC Global supports Jazz 2012
